## D. Approval of Dues Waiver Requests

The board discussed the report of the NHBA Waiver Subcommittee. Vice President Sandra Cabrera, a member of the subcommittee, outlined the criteria for requesting a waiver, and the process. The forms and process have recently been revised. Members are required to fill out a financial affidavit, and any that refuse to do so receive an automatic denial.

The committee report is attached as a permanent part of these minutes.

## **ACTION**

On motion to accept the recommendation of the Dues Waiver Subcommittee. Passed.

Director of Business Operations, Paula Lewis stated that it is a hardship on members that the board doesn't meet regularly during renewal season in July and August. She asked that the board empower the NHBA Waiver Subcommittee to grant the waiver requests over the summer and have the report come to the board in the fall as informational.

After some board discussion, President Dan Will suggested that the idea be tabled, and put on the agenda for the October 15<sup>th</sup> board meeting since it will require a by-laws change at a membership meeting.

# E. Creation of Special Ad Hoc Committee on Diversity and Inclusion Will

Dan

President Dan Will outlined the thinking behind the creation of this special committee. It was formed in response to the killing of George Floyd and the renewed activity of the Black Lives Matter movement. Bar leaders thought about whether the NHBA is aware of the diversity amongst its members and whether the association is doing what is should to promote inclusion and equality within its membership. They concluded that the best way to explore these questions would be to create this ad hoc committee. He added that this initiative is in no way politically motivated, but rather to be certain we are serving our entire membership in the best way, keeping in mind that the NHBA is a unified bar.

Prior to the meeting, the officers of the board and executive director drafted a mission statement for the proposed ad hoc committee, which is before the board today for approval. There was a lengthy discussion about the statement, as well as other related matters such as creation and make-up of the special committee, and the best way to proceed.

Cheshire County Governor Joseph Steinfield felt that the language charging the board to populate the committee with diverse members should be made stronger, and made the following motion to amend the mission statement as presented:

### **ACTION**

On motion to revise the second sentence in the third paragraph of mission statement of the NHBA Ad Hoc Committee on Diversity, Equality and Inclusion as follows:

"It will be chaired by [name], and membership will shall include at least one member of the Board of Governors, as well as association members of diverse backgrounds and perspectives."

Motion failed, 14 - 9.

### **ACTION**

On motion to approve the mission statement of the NHBA Ad Hoc Committee on Diversity, Equality and Inclusion as presented. Passed. Unanimously.

New Hampshire Bar Association -Ad Hoc Committee on Diversity, Equality and Inclusion Mission Statement

Since its inception, the New Hampshire Bar Association has been committed to equal rights for all citizens as guaranteed by the United States Constitution and the New Hampshire Constitution. The New Hampshire Bar Association reaffirms its commitment to equal justice for all citizens. As part of that commitment, the association promotes awareness and understanding among our members and the general population of the important role diversity plays in our profession and lives. To that end, the Board of Governors shall establish a committee, to address diversity and inclusion issues within our profession.

The committee is charged with examining the views of our association's membership regarding the role of the association in promoting diversity and inclusivity. The committee will, through survey, meetings with stakeholders and stakeholder groups and other means, (1) ascertain the makeup of our association, and (2) endeavor to understand what our association does well, what it does not, and what it needs to improve. The committee should consider, for example, whether the association should offer training on minority issues, including implicit bias, and develop credit worthy programs in conjunction with the CLE Committee, the Criminal Justice Section, the Ethics Committee, or any other appropriate group. The committee should consider whether our current association committee structure best promotes the interests of diversity and inclusion, or whether, a new permanent committee should be created to address these issues, or alternatively, whether an existing association committee(s) and/or section(s) should expand their missions to include these issues on an ongoing, permanent basis. The committee should identify concrete steps through which the association can promote diversity in bar leadership and promote interest in the practice of law in New Hampshire to diverse communities.

The committee will consist of at least seven members and no more than ten members. It will be chaired by [name], and membership will include at least one member of the Board of Governors, as well as association members of diverse backgrounds and perspectives. The committee will prepare a report of its findings and recommendations, to be submitted to the Board of Governors by [date].
