### **Association Overview**

Board Orientation Manual

George Moore

Executive Director George Moore discussed the Board of Governors' Orientation Manual. It can be found on the Board of Governors' page on nhba.org. Members thanked the staff for creating an electronic version. Staff will work on creating a downloadable, searchable version of the manual, and post the PDF to the web page.

• Tutorial on accessing and using the BOG Webpage

Debbie Hawkins

Executive Assistant Debbie Hawkins showed the board how to access the materials on the Board of Governors' web page, which is located on nhba.org, reached through the member portal, or dashboard.

To reach the Board of Governors Committee page, board members must log into their dashboard through the portal. Once they are on their home page, they will see a heading *MyCommittees* located under *My NHBar*. The Board of Governors should be listed there. Click on that, and it will bring you to the Board of Governors home page. Agendas and materials for upcoming board meetings, reference materials including the Board Manual, and past meeting materials and minutes can be found here. For assistance with the web page, contact Debbie or Allison in the Executive Department.

Debbie also showed the board members where the NHBA Member Benefits resources are listed on the NHBA web site.

• Overview of the five entities that are located within the Bar Center

George Moore

Executive Director George Moore reviewed the four separate organizations that are housed within the Bar Center. (There formerly were five including the NHBA Insurance Agency, which was sold earlier this year to Amity Insurance of Massachusetts.) The four remaining entities are the New Hampshire Bar Association, the NH Pro Bono Referral System, the New Hampshire Bar Foundation, and NH Supreme Court Rule 53 (NHMCLE) office. These organizations have separate budgets.

• Brief overview of the Association's financials & Board financial responsibilities and budgeting process

Paula Lewis

Director of Business Operations Paula Lewis spoke generally about the Association's budgeting process. There will be some changes for the current year, one of which is a greater focus on promotion and marketing. The NHBA process of drafting the budget begins in January. Each director submits a draft budget for their department/organization that is reviewed by the Finance Committee. Once the Finance Committee finishes their review process, the draft budget is brought to the full board for a vote, usually at the May meeting.

Paula noted that the NHBA has a zero-based budget, meaning that the budgeted expenses and revenues are equal. The organization has had a positive contribution annually for the last 10 plus years, which has contributed to the organization's reserves and programs.

Paula also explained that the NHBA has revenue that comes from sources other than dues. Ed added that as a part of his speech to the new admitees, he notes that the cost of bar dues are less than three months of basic cable. Much of the amount that members pay are court fees that fund NHMCLE, the Attorney Discipline system including the Professional Conduct Committee, NHMCLE and the NH Lawyers Assistance Program. This is spelled on the dues bill.

• Update on 2019 - 2020 Membership Renewal

Director of Business Operations Paula Lewis updated the board on the current status of this year's membership renewal process. There are currently 164 members out of 8,100 not in compliance; last year at this time there were 576. (This does not include those that only owe delinquency fees.) Including those that only owe delinquency fees, there are 221 not in compliance as of September 12<sup>th</sup>, compared to 760 last year at this time.

Paula feels the numbers are lower this year due to increased outreach, as well as working with the NHBA Marketing & Communications staff to revise the communications to members via the NH Bar News, eBulletin and direct email.

Executive Director George Moore highlighted the excellent personalized service that NHBA members receive from staff to help them complete their annual licensure renewal.

Justice Bassett commented on the improvement he has seen since the implementation of the online process several years ago.

#### • Tremendous Bar Exam

George Moore

Executive Director George Moore distributed the 'Tremendous Bar Exam' a multiple-choice test about NHBA Member Benefits and gave the members of a board a few minutes to complete it. The group then reviewed the correct answers. The board thought this was most helpful.

# Initiatives for the Coming Year

# • Tech -Connect Program

Executive Director George Moore announced this program will go live on September 25<sup>th</sup>. It will provide tech advice and support for members, especially solo and small firm practitioners. The service is available to all NHBA members. The NHBA partnered with Affinity Consulting to provide this service. There will be an article in the September Bar News with more detail. Ed added that 71% of our members are solo practitioners, and 92% are in firms of 5 or less.

# Manual on Planning for Medical Events and Closing Practices

Executive Director George Moore will initiate the process of drafting this manual. He may ask for board volunteers to assist him if they have interest. There was discussion about members designating a support lawyer, someone that knows some details about an attorney's practice. George states an electronic and paper print version will be developed. Some bars have a repository at the Bar Association. This initiative is in the planning stage; he foresees potential involvement by members of the NHBA Ethics Committee as well as the Board of Governors.

# • Encryption Services

There have been inquiries by NHBA members about offering services from companies that provide encryption. Our Tech Connect partner Affinity can give advice to members. George shared that we are in the process of vetting some encryption service providers that could possible partner with the NHBA. There will probably be a cost to members who opt to use the potential service. We will use Affinity to assist us in the vetting process.

# • 19<sup>th</sup> Amendment Program

President Ed Philpot shared that 2020 is the 100<sup>th</sup> anniversary of the passage of the 19<sup>th</sup> Amendment, granting women the right to vote. The NHBA's Law Related Education (LRE) Committee is working with the NHBA Gender Equality Committee and the NH Women's Bar Association on creating programming for the upcoming year. This is the American Bar Association's theme for Law Day 2020. There is a travelling exhibit that we have reserved to use for Law Day, May 1, 2020. A toolkit will be put together for attorneys to use in classroom presentations. There may also be some programming at the NHBA Midwinter meeting on this topic. Jennifer Eber is chair of the LRE Committee. US District Chief Judge Landya McCafferty has also agreed to serve on the committee.

#### LRE/Civics

President Ed Philpot, LRE Committee Chair Jennifer Eber, and LRE Coordinator Robin Knippers have been participating in a statewide civics' roundtable. The NHBA has a long history of promoting civics education, having done so for many years. He shared that there will be some exciting discussions taking place this year.

Executive Director George Moore urged board members to talk about these programs and encourage involvement of their colleagues.

# **Board Meetings this Year**

Ed Philpot Jr./George Moore

• How to make meetings more interactive, involved and interesting?

President Ed Philpot announced the format of the board agenda will be changed to put the consent items first. He feels this will give the board more quality time to discuss substantive issues. His personal belief is that a meeting longer than 2 hours is not productive; he is hoping to make meetings as efficient as possible.

As agreed at the board retreat last year, each month, copies of preliminary agenda for officers meetings will be circulated one week prior to the officers' meeting to give board members an opportunity to submit questions or comment on proposed topics. There are some things that are acted on by the officers and not the full board.

Ed is looking for input and opinions from board members at the early stages with the goal of increasing the efficiency of the governance process.

Ed reminded the board that they are the conduit to information from local, county and specialty bars. He notes that he finds complaints from members often are due to misconceptions. Board members are the best ambassadors for the Association. We serve a variety of members; public sector attorneys, those in large firms, as well as solos and those in small firms. Some issues touch all our members, such as technology in court rooms.

Executive Director George Moore shared that the most successful boards are active and innovative. Debate is a healthy thing; please speak up.

President Ed Philpot asked that the board please respond to requests from the staff in a timely manner.

# **Brief General Group Discussion and Break Out Sessions**

Ed Philpot Jr.

The board and staff were divided into five groups to address the following questions. The results were reported in the afternoon, along with the breakout group results of advantages and disadvantages of unified and voluntary bars.

- What is the Bar doing well?
- What is the Bar doing poorly?
- What things should stay the same?

- What things should be increased/embellished?
- What things should be decreased/downplayed?

# National Deunification Issues

George Moore

Executive Director George Moore gave background on this. The present issues arise out of the <u>Janus</u> decision by the US Supreme Court that held that a nonunion members' first amendment rights are violated when the union compels them to pay dues against their will. There are now cases pending in seven states, all of which involve challenges to mandatory Bars. These are all funded by the Goldwater Institute, a conservative and libertarian public policy organization. <u>Fleck</u> is the leading case of these. The NHBA has joined a working group led by the Michigan Bar to monitor the situation. The 8<sup>th</sup> Circuit Court recently ruled against Fleck, but this case will be appealed to the US Supreme Court. There are strong concerns by several commentators that the <u>Janus</u> decision does not bode well for mandatory bar associations.

It is not clear whether these issues will effect New Hampshire, either directly or indirectly.

In preparation for this meeting, George reviewed historical NHBA files from when the bar was unified in 1968 and shared some thoughts of members at that time.

# Advantages & Disadvantages of Unified vs. Voluntary Bar

He also asks board members to consider how best to connect to and support local/county bars.
