A meeting notice reminder, a link to the preliminary agenda and related materials were emailed to all Governors on February 7th. The agenda is duplicated below in the order of consideration of agenda items. A. Call to Order Dave McGrath

President David McGrath called the meeting to order at 4:41 p.m.

PRESENTATION / DISCUSSION / ACTION ITEMS

B. Report from the Legislation Committee

John MacIntosh

NHBA Lobbyist John MacIntosh reported that he reviewed over 885 legislative service requests and winnowed the list to approximately 60 to 70 bills that were reviewed by the Bar's Legislation Committee. The committee met for 4 weeks. John also reported that there are big changes in the Legislature this year with the leadership changing to the Democratic party. He also shared that there are many new younger representatives, and the major issues of concern this year appear to be social in nature. Hot topics are education funding, the death penalty and election requirements.

John reviewed the positions that could be taken on legislation; Oppose, Information Negative, Information, Information Positive, Support and No Position. The informational positions are often chosen when a bill is badly written, and the committee feels they can provide technical assistance or correction. Due to the unified status of the NHBA, the bar cannot take a position on bills that would not have substantial unanimity across its membership, so in these cases, often No Position is chosen. The committee took positions of Information Negative on 10 bills, Information Positive on 2 bills, Information on 8 bills, Oppose on 4 bills, and Support on 1 bill.

He discussed highlights of the bills the Legislation Committee did take a position on.

- Oppose Two bills HB 217 Relative to bond for public employees and repealing the board of claims and HB 246 Relative to penalties for corrupt practices. Both have been found ITL (Inexpedient to Legislative) which effectively kills them. HB 314 Relative to the submission of evidence prior to hearings in divorce cases has not been scheduled for hearing yet, but the committee was unanimous in its opinion that this would not be practical in divorce matters. The committee also initially opposed SB 298 Relative to summoning out of state witnesses in criminal cases, but upon gathering further information, John is recommending a change to perhaps an informational role. Both the NH Criminal Defense Lawyers' Association and the NH Association for Justice are supporting this bill.
- Support SB 147 Relative to the Adoption of the Uniform Fiduciary Access to Digital Assets Act- this is a redo of a bill that the Board supported two years ago. Currently, an executor does not have access to digital assets, which can range from bank accounts to social media accounts. Similar legislation has been adopted by 28 states and is supported by the NHBA's Trust and Estate Section. This bill's predecessor sailed through the Senate and the House committee and then was killed by one representative.

ACTION

On motion to accept the Legislation committee's recommendations with the exception of SB 298; change position on SB 298 from Oppose to Support. Passed. Unanimously.

The Board discussed whether the Bar should take a position on SB 296 – Relative to live medical testimony in courts. John MacIntosh shared that the Legislation Committee did not feel there would be substantial unanimity across the membership of the Bar and therefore taking a position could create a Chapman issue. The Board discussed taking a position of Information. It was agreed that most members of the Bar would agree with this position.

ACTION

On motion to change position on SB 296, Relative to Live Medical Testimony in Courts from No Position to Information. Passed. 12 - 3.

C. Dispute Resolution Committee Arbitration Rules and Procedures

George Moore

Executive Director George Moore spoke about the background behind this change. At the Board's December meeting, they requested that arbitration remain an option for those using the services of Dispute Resolution Program, so the past version of arbitration rules and procedures were revised and added back into the Dispute Resolution Committee General Provisions and Procedures document approved at the December 2018 meeting.

ACTION

On motion to accept the Dispute Resolution Committee Arbitration Rules and Procedures as presented. Passed. Unanimously.

George Moore

D. Establish Special Committee of Board of Governors to Manage Oversight of Amity Insurance Agency Inc.

Executive Director George Moore referred to the proposal included with the Board materials. This committee will be established for the purpose of monitoring the provision of insurance services by Amity Insurance Agency Inc. and the contractual obligations incidental to the sale of the NHBA Insurance Agency to Amity Insurance Agency, Inc. The members of the committee shall be identical to the membership of the former NHBA Insurance Agency Board. This shall be a NHBA special committee.

ACTION

On motion to approve the formation of a special committee of the NHBA for the purpose of monitoring the provision of insurance by Amity Insurance Agency, Inc. and the contractual obligations incidental to the sale of the NHBA Insurance Agency to the Amity Insurance Agency, Inc. Passed. Unanimously.

E. President's Report

Dave McGrath

1. Harassment Training March 4th at 3:00 p.m.

President David McGrath reminded the board that the start time was changed from 2:00 p.m. to 3:00 p.m. This training has been set up as a best practice under the guidelines of the ABA. The NHBA staff will participate in a similar training the morning of March 4th.

F. Executive Director's Report

1. MYM Mobile App

The number of downloads is being tracked. The feedback from users has been positive.

2. Reduced Fee/Free Solo and Small Firm Flight plan CLE (May 10) for Solo and Small Firm practitioners

The decision has been made to reduce the cost of some of the CLE programs aimed at solo and small firm practitioners as a member service. Board members are encouraged to spread the word to those that can benefit.

3. PR Efforts for Dispute Resolution Program

Executive Director George Moore shared there will be increased publicity in the coming months about this service. It has been in existence for 30 or more years. There will be a Bar News article in the form of a Q and A with chair Charles Bauer in a future issue.

There was discussion about destruction of files by the district courts. Executive Director George Moore will follow up on the issue with the Committee on Cooperation with the Courts and report back to the Board.
