D. Report on Dues Waiver Requests

The Board approved the following nine (9) August waiver requests:



- 100% waiver of the Active Bar dues and Court fees.
- 100% waiver of the Active Bar dues and Court fees.
- 50% waiver of the Active Bar dues and Court fees.
- 100% waiver of the Active Bar dues and Court fees.
- 50% waiver of the Active Bar dues and Court fees.
- 100% waiver of the Active Bar dues and Court fees.

- Deadline waived in order to resign.

The Board approved the following five (5) waiver requests at the September 19th meeting:



- 75% waiver of 2017-2018 Inactive Court fees, Bar dues and delinquency fees in order to resign was approved contingent on resignation within 30 days.
- Waiver of 2017-2018 Licensure Renewal Late Delinquency fee of \$50
- 50% waiver of back dues in order to be reinstated and resign
- 100% waiver of 2017-2018 Active Court fees, Bar dues and delinquency fees
- Waiver of 2017-2018 Inactive Retired Licensure Renewal Late fees of \$100, in order to resign

Governor-at-Large and Waiver Subcommittee member, Paul Chant, explained the types of requests the Bar receives and the committee's philosophy in handling such requests; to be compassionate but not taken advantage of. We have members struggling with a variety of hardships that make it near impossible for them to pay their Bar dues and Court fees.

Our current policy is to require a \$20 administrative fee for any member receiving a 100% waiver. This is taking an unreasonable amount of staff time in attempting to collect from members that are suffering enough with financial hardships. The Committee asked the Board to abolish the \$20 administrative fee.

ACTION

On Motion to abolish the \$20 administrative fee for members receiving a 100% waiver of NH Bar Association dues and NH Supreme Court fees. PASSED.

The September 19, 2017 Board of Governors Meeting adjourned at 4:05 pm.
