REGULAR SESSION

A. CALL TO ORDER

Lisa Wellman-Ally

The Regular Session of the June 18, 2015 Board of Governors meeting was called to order at 6:30 p.m. by President Lisa Wellman-Ally.

New Board members Chris Marshall (Public Sector Governor) and Peter Hutchins (Treasurer) were introduced.

PRESENTATION / DISCUSSION / ACTION ITEMS

B. Advocating Support for Adequate LSC Funding

Lisa Wellman-Ally

President Lisa Wellman-Ally reported on the Congressional debate for increased funding for The Legal Services Corporation in 2016. This is one of the topics our Association ABA Delegate Russ Hilliard discussed with the NH delegation in Washington during ABA Day in April.

Board members were encouraged to support adequate LSC funding. NH's LARC program was created to receive LSC funding, from which our own Pro Bono program gets a small, but important, sub-grant. Overall, grant funds are down and this will have an impact on all grantees.

Executive Director Jeannine McCoy asked the Board to consider granting authority to the leadership to advocate for adequate LSC funds if asked to do so.

ACTION

On motion to authorize the Board to officially advocate for adequate LSC funding to the NH Congressional Delegation, if asked. PASSED (unanimously).

D. Banking Resolution to Enable Remote Check Deposit

Paula Lewis

Director of Finance & IT Paula Lewis explained to the Board the time it currently takes for Bar staff to travel around Concord making deposits in all of the banks at which NHBA has accounts. The current process is neither efficient nor particularly secure.

On motion to approve Bank of New Hampshire remote deposit capture and ACH functions for more secure and efficient check deposit processing as presented to the Board of Governors. PASSED (unanimously)

H. Executive Director's Report
Bar Center Use and Financing Update

Jeannine McCoy

Director of Finance & IT, Paula Lewis, provided a financial overview for the current fiscal year through April 30, 2015 (11 months). The Association has a healthy financial outlook, with total cash on hand at 4/30/15 being \$1,504,928.

Executive Director Jeannine McCoy reported that 6,958 renewal notices were sent via email and 647 via U.S. Mail, for a total of 7,605 renewal notices sent. Jeannine also explained the history behind the Professional Conduct Committee/Attorney Discipline Office fees and the Lawyer Assistance Program fees that the Bar collects on behalf of the Court.

Jeannine also recapped details of the lease and subsequent purchase of Bar Center space at 2 Pillsbury Street on the third floor and lower level. Member usage of the Bar Center over the past year was also noted.

Jeannine thanked Paula Lewis and her staff who had to pull some very late hours this year in order to get the dues processing completed. There were some equipment issues which Mainstay Technologies was able to identify and address.

I. Around the Board Table

Coos County Governor Sandra Cabrera reported that Coos County Bar Association will be scheduling a meeting this fall. Details will be provided once finalized.

Immediate Past President Jaye Rancourt reported that the Access to Justice Commission met to discuss recommendations of the Executive Committee. There was no real agreement on any of the recommendations so the Executive Committee will be meeting again to winnow down the list. Jaye mentioned some of the recommendations discussed.

Governor-at-Large Jacki Smith reported on a conference held last week on veterans issues and needs. Jacki also reported that the Court system has been infected with a computer virus, so be cautious about any emails you receive from the Court system.

Governor-at-Large Ed Philpot reported that Belknap County still offers the SCOPE program twice a month and it is very successful.

Vice president David Ruoff reported that the Access to Justice Commission has lots of good ideas. David also provided a PCC update, the ADO has hired 2 new prosecutors and 1 assistant general counsel position. They are focusing on clearing the backlog of cases.

President-elect Mary Tenn emphasized the importance of the initial review process of complaints. A discussion about the costs to members of running the ADO, the backlog and the overall process ensued.

J. President's Report

President Lisa Wellman-Ally reported that the Rural Access project has received its first application from a member looking to open a law practice in Warner, NH. The deadline for applications is July 1. Lisa anticipates a meeting in July to "get the ball rolling" on the project. Arthur Greene will be "first up" to help with providing alternative billing options.

Lisa thanks everyone for their courtesy and cooperation this year and she is looking forward to working with Mary Tenn this coming year.
