G. President's Report

Jaye Rancourt

President Jaye Rancourt reported on the following:

- Justice Initiative "Challenge" Update commitments from many of the Board members have been received, thank you. Webpages are being finalized, with a "go live" date of March 1. The official roll-out will be March 7 at the Midyear Meeting. Board members were encouraged to go on and sign-up March 1. Jaye will demonstrate, at the Midyear Meeting, just how easy it is to sign-up. NHLA and LARC Boards are "on board" too.
- Dating Violence Program for A Lawyer/Judge in Every School Day Update Information will be distributed at the Midyear Meeting, asking members to volunteer to either give the presentation in a school or recruit a school that would like the presentation. The program will be ready for May 2, A Lawyer & Judge in Every School Day.
- March 7<sup>th</sup> Midyear Meeting the Governor will be speaking at the Gender Equality Committee Breakfast, which is sold out. The luncheon will feature a "new lawyers" showcase, including comments from Ned Sackman, Quinn Kelley and the 2 pro bono Rising Stars.

The March Board Meeting is a dinner meeting on Thursday, March 6 beginning at 4:30 pm at the Radisson hotel in Manchester.

- H. Client Indemnity Fund (CIF) Report on Durham v Tessier

Public Protection Fund Vice Chair Chuck Grau explained that on May 16, 2013 the New Hampshire Bar Association Board of Governors reconstituted the CIF Committee and appointed attorneys Thomas Quarles, Charles Grau, Keith Diaz, Thomas Irwin and Neil Nicholson to decide the Durham v Tessier claim. (The claim resulted from a situation

occurring during the time the Client Indemnity Fund was in place.) The Client Indemnity Fund denied the claim. Discussion followed.

#### **ACTION**

## I. Rudman Center Update

Erin Corcoran

Erin Corcoran, Executive Director of the Rudman Center, reported that the hallmark of the Rudman Center (launched in April 2013) will be the Rudman Fellows program, which will select entering law students each year and develop their interest and skills in public policy. 20 Fellowships will be offered this summer, with about half of them being in NH.

Erin noted that they would like a Board member to serve on the Rudman Center Board going forward, and the Rudman Center looks forward to collaboration with the NHBA on various initiatives.

J. President's Report (continued)

Jaye Rancourt

President Jaye Rancourt reported on the following:

■ BOG Recruitment – there are two individuals interested in filling the Public Sector seat, so having a Nominating Committee to speak with the individuals and make a recommendation to the Board seems to be the best approach. Governor-at-Large John Curran, Hillsborough North Governor Scott Harris, and Immediate Past President Larry Vogelman will serve as the Nominating Committee for this position. A recommendation will be put forth at the March Board Meeting.

It was also noted that it is too late to include the Out-of-State seat on the Nomination Petition for the 2014 election. There was some discussion about appointing someone to fill until the next election cycle, or simply not filling the seat until the next election cycle in 2015. The consensus was to advertise the seat, have interested members respond, and appoint a nominating committee to interview those interested and make a recommendation to the Board to fill the seat, by appointment.

K. Court Rules Process and temporary amendments to Rule 98 of the Rules of the Superior Court

Richard Guerriero

Cheshire County Governor Richard Guerriero explained that the criminal case flow rule takes effect April 1<sup>st</sup>. All deadlines are moved forward in an effort to make the criminal process more efficient in Superior Court. Richard outlined some of the deadline date changes.

Immediate Past President Larry Vogelman noted that he is on the committee to look at revising the Supreme Court Rules Committee process and will be meeting for the first time next week.

#### L. Veterans Initiative Update/Discussion

Larry Vogelman

Immediate Past President Larry Vogelman reported that Pro Bono is working with the VA to host a number of clinics for veterans and that CLE has provided training for judges and lawyers on veterans issues. Larry has been attending many, many meetings on the issues surrounding veterans needs, including meeting with Veterans Count.

Board members expressed support for continued exploration of how the Association can best be involved in this service initiative. It was noted that the Association's potential involvement should be evaluated based on structural expectations, adequate funding and alignment with the strategic plan.

M. Legislation John MacIntosh

NHBA Lobbyist, John MacIntosh reported recommendations for positions on 27 bills. Guided by standards set by the *Chapman* and *Keller* decisions, the Board viewed the recommendations for positions on 27 bills using the Legislation Watch website, which provides access to the official General Court website with an informational overlay containing information on the Bar's legislative review process.

The Board moved to the remaining bills, and after further discussion, approved or ratified the Legislation Committee's positions on the following bills (L. Witkus abstained):

#### N. Executive Director's Report

Jeannine McCoy

Assistant Executive Director Denice DeStefano reported on the potential purchase of 46 Pillsbury Street, by the 2 Pillsbury Street Condo Association, for the purpose of adding another parking lot with 32 parking spaces, to the 2 Pillsbury Street Condo Association property.

NHBA owns the Bar Center space on the third floor, the seminar room, kitchen and storage space in the lower level of 2 Pillsbury Street. Denice DeStefano is the Association's designated representative at the 2 Pillsbury Street Condo Association Board Meetings and at 2 Pillsbury Street Condo Association Owners Meetings.

Denice noted that the Condo Association is waiting to get a copy of an appraisal being done for the current owner of 46 Pillsbury Street (Steve Duprey; also the developer and primary owner of units in 2 Pillsbury Street). Once an appraisal is in-hand, the 2 Pillsbury Street Condo Association Board can determine, based on estimated demolition, removal of the structure(s) and site work to build the parking lot, what price they will offer Mr. Duprey for the purchase of 46 Pillsbury Street. The 2 Pillsbury Street Condo Association Owners must approve, unanimously, the purchase of and the price for 46 Pillsbury Street.

Denice explained what is being done to obtain additional demolition and construction bids, to acquire additional financing options, to address any requirements that may be placed on the project during the Site Review process by the City of Concord and to minimize the potential impact on the operating budget going forward. The Board was asked if they had any initial questions or concerns with what has been outlined thus far. The suggestion was made that an independent review of the Purchase and Sales agreement should be done.

The Board will be kept apprised of the details as they become available.

Executive Director Jeannine McCoy reported on the following:

ABA Action Alert – outlined the issues on Tax proposals that adversely affect many lawyers and law firms. NHBA is being asked to adopt a Model Resolution opposing these provisions in the draft legislation and send it to our Congressional delegation, urging them to oppose the legislation and to convey their views to the relevant Committee leaders.
