REGULAR SESSION

A. CALL TO ORDER Jaye Rancourt

The Regular Session of the May 15, 2014 Board of Governors meeting was called to order at 3:00 p.m. by President Jaye Rancourt.

Minutes of the April 17, 2014 Board of Governors meeting were approved as presented.

PRESENTATION / DISCUSSION / ACTION ITEMS

D. NH Judicial Council Update

Chris Keating

NH Judicial Council Executive Director Chris Keating reported that the Judicial Council established, in April, plans for the participation of the private bar in the delivery of indigent defense representation in NH. The Indigent Defense Subcommittee of the Judicial Council will ensure the terms of the plan are carried out.

Elements of the plan are:

- Conflict Case Administrator the Public Defender Program will maintain an office to assign conflict cases in an orderly, fair and transparent manner.
- Contract Attorney System the Judicial Council will enter into contracts with private attorneys to provide representation in court-appointed criminal and delinquency cases.
- Limits on the Number of Contracts and Units Awarded Each Year limits will be set on the number of contracts awarded each year based on the regional projected need for representation in conflict cases.
- Assigned-Counsel System establishes three panels for defense representation as follows:
 - o Misdemeanors, Delinquencies and Felonies
 - o Major Crimes and Homicides
 - Supreme Court Appeals
- Eligibility Criteria for Defense Counsel this component is critical to the success of the plan. Indigent defense representation is not a "training ground" for new or inexperienced lawyers.

The question was then asked about increasing contract attorney fees. The last time contract attorney fees were adjusted was in 1992. Chris Keating asked if the Board of Governors would be supportive of such an effort. Rates currently are set in the Court Rules so it would require a Rule change.

After discussion and questions/answers, President Jaye Rancourt asked for a small group of Board volunteers to work on this effort. If interested, please let Jaye know.

E. Welcome to Mary Ann Dempsey

President Jaye Rancourt welcomed Mary Ann Dempsey to the Board as the Public Sector Governor who has been appointed to complete the unexpired term of Chuck Temple (who has been appointed to the Bench).

F. Approval of FY 2014-2015 Budget

Director of Finance & IT Paula Lewis recapped the minor changes in the budget from the current fiscal year to the proposed budget under consideration. Treasurer Rob Howard provided an overview of the budget draft for fiscal year 2014-2015.

Executive Director Jeannine McCoy noted that this is year 5 at the same dues rate which makes balancing the budget more difficult without making cuts in programming.

- Bench/Bar Meeting Report the recent Supreme Court Bench Bar meeting was a positive meeting.
 Most of the justices will be in attendance at the Annual Meeting banquet.
- Teen Domestic Violence ALIES Curriculum the program is up and running and has been very well received in the 9 schools visited during the initial rollout. Twenty more attorneys are being trained, in the next week or so, in how to present this program. The LRE Coordinator is now scheduling fall dates with schools wishing to have this program presented to their students.
- Justice for All recruitment efforts continue and will be encouraged at the Annual Meeting in Portsmouth.
- 2014 Annual Meeting Board members were encouraged to make their room reservations at the hotel, register for the meeting and "talk it up."
- Department of Defense Letter if anyone has feedback on the military justice system in NH, please let Jaye know and she will be happy to provide it to the Dept. of Defense in response to their letter.

K. Association Recognition at Annual Meeting

President Rancourt reported on concerns she has received about the Association recognizing retired Judge John Lewis at the upcoming Annual Meeting.

At issue is the appropriateness of the Association recognizing Judge Lewis at the NHBA Annual Meeting in light of his comments, particularly those regarding women lawyers, as described in the Judicial Conduct Committee Reprimand of April 1, 2014. [EXECUTIVE DIRECTOR'S NOTE: See 5/22/14 minutes; this vote was reconsidered and rescinded in a motion to recognize all retired judges at 2014 NHBA Annual Meeting.]

A lengthy Board discussion ensued.

On motion to not include Judge Lewis in the list of retired judges being recognized at the NHBA Annual Meeting on June 20, 2014. PASSED (8-yes; 6-no; 4 abstained: L. Witkus, J. Smith, S. Harris, P. Hutchins).
