DISCUSSION / ACTION ITEMS

F. Welcome of New ADO Discipline Counsel

Thomas Trevethick, general counsel, Attorney Discipline Office, introduced Sara Greene as the newly appointed disciplinary counsel for the ADO. She previously represented respondents in disciplinary hearings and did other civil litigation in Arizona. As such, she said that her past experience means she will be sensitive to the concerns of respondents when they are facing complaints or charges in the disciplinary process.

G. Legislation

NHBA Lobbyist John MacIntosh reported that fewer than the average number of bills have been introduced for an initial session of the biennium – 700 bills are expected to be introduced.

The Board viewed the recommendations for positions on three bills using the Legislation Watch website, which provides access to the official General Court website with an informational overlay containing information on the Bar's legislative review process.

After some discussion, the Board unanimously approved positions taken on three bills:

CACR 4 – Oppose.

HB 107 – Information.

HB 116 – Information.

H. New Lawyers Committee Proposal for New Action

Francesca Hennessy

Francesca Hennessy, of the New Lawyers Committee and a graduate of the Leadership Academy, Class of 2012, described proposal by the Committee to continue an orientation project, "Fostering Legal Independence" for young adults aging out of the foster care system on their legal rights and responsibilities, along with some career advice. The project calls for 2-3 sessions to be held at different locations in the state with small groups of adolescents, with

NLC volunteers doing the presentations. This is a continuation of a Leadership Academy service project begun last year.

ACTION

Motion to approve continuation by the New Lawyers Committee of the "Fostering Legal Independence" project, as described. An expenditure of \$150 from the NLC Committee was approved for miscellaneous expenses with the program. Unanimously approved.

I. Supreme Court Rules Committee; BOG Priorities/Concerns Outline Peter Hutchins Lanea Witkus, Scott Harris, Jennifer Parent

Peter Hutchins commented on a memo he submitted with commentary and concerns regarding Rule 170 mediation.

Comments from board members included further consideration of the question of whether there should be registration fees for mediators to participate as volunteers. In addition, is a requirement for ongoing training required for experienced mediators? Lastly, it was suggested some measures should be taken by the Court to provide recognition of the participation of these volunteers. No formal action was taken, but these issues will be discussed at upcoming Bench/Bar meetings.
