## **EXECUTIVE SESSION**

C. Public Defender Contract Renewal (Jacki Smith abstained)

RSA 604-B:4 calls for NHBA approval of any Public Defender Program with which the state intends to contract. Statute Excerpt: **604-B:4 Contract.** – The state of New Hampshire, by the judicial council and with the approval of governor and council, shall contract with any organization or groups of lawyers approved by the board of governors of the New Hampshire Bar Association to operate the public defender program and provide public defender representation as provided in RSA 604-B:2 and 3. The contract shall fix the number of defender attorneys providing representation in each county and shall permit the public defender program to subcontract for attorney services, including appellate services, as may be necessary to provide such representation. No such contract shall be effective for longer than 2 years. The compensation for operation of the public defender program shall be such sums as may be fixed by the contract, subject to the appropriations made therefore.

## **ACTION**

The **Board approved** a Resolution approving the NH Public Defender "as an organization to operate a Public Defender Program and provide Public Defender representation for the State of New Hampshire for the 2011-2013 biennium."

## D. Legislation Committee Report

The Board ratified Informational positions on the following bills as recommended by the Legislation Committee.

HB305; HB378; HB405; HB510; HB522\*; HB536\*; HB546\*; HB563\*; HB567\*; HB587\*; HB591\*

\*It was noted that these bills have been found 'inexpedient to legislate' or have been retained.

The Board ratified a Generally Favorable position on HB 609, as recommended by the NHBA Legislation Committee.

The Board ratified a Generally Unfavorable position on HR 7, as recommended by the NHBA Legislation Committee.

Legislative Representative John MacIntosh provided current updates on various bills. He pointed out that the NHBA Legislation Committee has done a lot of work during the session, reviewing over 1000 bills – 150 of those intensively.
