## PRESENTATION / DISCUSSION / ACTION ITEMS

G. Request of the Elder Law Section to file an Amicus Brief Marilyn McNamara

President Marilyn McNamara recapped the issues surrounding the Elder Law Section's request to file an Amicus Brief on a matter pending before the NH Supreme Court that could have a significant impact on the ability of those who seek guardianship over their relatives to have their legal costs covered.

Board members discussed the merits of filing a brief and their concerns with taking positions in private cases.

Because this is an important issue that affects lawyers, litigants and proposed wards, it is the consensus of the Board that the New Hampshire Chapter of the National Association of Elder Law Attorneys might be a more appropriate organization to consider whether or not to file an amicus brief in this matter.

#### Action

On motion to deny the section permission to file an amicus brief in support of the Laboe Law Office's position in this matter. PASSED (unanimously).

H. President's Report, Including:

Marilyn McNamara

- Report on ABA Task Force on the Preservation of the Justice System Meeting held in NH May 26<sup>th</sup> – Marilyn testified along with others including clients of Attorney Kirk Simoneau and Chris Seufert, who were very effective.
- NHBA Annual Meeting & Business Meeting Marilyn welcomed Board members to the Annual Meeting and invited them to stay for the Business Meeting immediately following.
- Marilyn welcomed new Grafton County Governor Jason Crance to the meeting and the Board.

# I. President-Elect Report, Including:

Jennifer Parent

- Report on Rules Committee Public Hearing held Friday, June 17, 2011 Jennifer reported that all the rules considered at the June 17<sup>th</sup> Public Hearing were sent to the Supreme Court. The Attorney Discipline Office has suggested a change to the Ethics Rule on Trust Accounting (using the ABA's Rule). The Rules Committee referred this to the Bar's Ethics Committee for review and recommendation.
- Leadership Academy Graduation takes place Saturday evening at the Annual Meeting Banquet. All 16 graduates will be in attendance. Planning is well underway for next year's Leadership Academy program, to be co-chaired by Richard Uchida and Jaye Rancourt.
- Circuit Court Circuit Court plans are being implemented on July 1<sup>st</sup>. The
  Association is hosting a Circuit Court webcast on Thursday, July 14<sup>th</sup> at noontime
  with Circuit Court Administrative Judges Ed Kelly and David King.
  Jennifer noted that there will be challenging times ahead while Circuit Court
  implementation is occurring.
- E-Court the Court is establishing a Committee to implement e-Court; Justice Hicks will be the chair. The Court has asked for names of representatives from the Association and Committee on Cooperation with the Courts for possible inclusion. This will be a slow process notwithstanding the necessary funding that will be required to implement e-Court.
- Other Jennifer & Executive Director Jeannine McCoy will be meeting with each of the Board members prior to the August Board orientation meeting. The Board Orientation meeting is August 18<sup>th</sup> in Portsmouth, to be followed by a harbor cruise reception.
- J. President Marilyn McNamara read a thank you card from recently retired *Bar News* Editor Beverly Rorick. Beverly will be a 'special correspondent' from time to time for *Bar News*.
- K. Reporting on Issues, Interests, Concerns from Association All Board Members
  Member-Constituents Around the State

President Marilyn McNamara reported on the retirement party for Merrimack County Clerks Kathy McDonald and Jim Warren. The event was well attended and very poignant.

Governor at Large Jaye Rancourt reported on the NH Assn. of Criminal Defense Lawyers concern that a new court procedure will the unintended result of counsel potentially being conflicted out.

Strafford County Governor Chris Regan reported on a retirement party for Joanne Sullivan of the Dover District Court. Chris also reported that there is a great deal of apprehension in Strafford County about the circuit court implementation. Also concern

surrounding the issue of no payments for attorneys of indigent parents in abuse and neglect cases.

Carroll County Governor Chris Meier reported that he has attended 6 retirement parties for court clerks over the course of 2 weeks. Three of the six may return in a part-time capacity.

Immediate Past President Jim Tenn noted that this is a good opportunity for the bar to demonstrate the value of lawyers in the court process.

Rockingham County Governor Phil Pettis reported the Rockingham County Bar is doing well and has a good group of officers in place.

Coos County Governor John McCormick also reported on retirement parties for long time district court staff. A Court Appreciation event for Coos County was well attended.

Incoming Grafton County Governor Jason Crance reported the Grafton County Bar summer meeting was well attended. The County Bar is pleased to be hosting the November Lawline. Concerns abound re: e-filing for the many clients without internet access.

Vice President Larry Vogelman reported the lack of attorney fees for representation of indigent parents who are parties in abuse and neglect cases is an issue.

Belknap County Governor Catherine Broderick reported the Belknap County Bar Annual Meeting is June 30<sup>th</sup>.

President-elect Jennifer Parent reported that the decision to eliminate funding lawyers representation for indigent parents involved in abuse and neglect cases came from the Judicial Council and is strictly in response to severely decreased funding. Circuit Court implementation is also of concern.

- Judge Michael Feeney is at Dartmouth and a Caringbridge website has been setup to keep folks informed on his progress.
- Circuit Court Implementation patience and communication will be key while this transition occurs.
- Chief Justice Dalianis, Judge Kelly, Judge King and Jennifer Parent, talking about the circuit court implementation, appeared on the last NH Outlook show, filmed this past week. The show is broadcast on NHPTV, with a link on www.nhbar.org.
- Noted the opportunity for Bar support and assistance by being involved in the e-Court process.

  - More demand on pro bono while funds have been cut. We are scrambling to keep the minimal staff we have for Pro Bono.
  - Jeannine recently met with Dean Broderick at the UNH School of Law and plans are underway to resurrect the program initiated by the Association in 2004 to encourage more law student involvement with the NHBA.
  - A Section Leader orientation and information session will be held June 30.
- M. Vice President Larry Vogelman thanked the Amazing Bar Staff and requested that they stay amazing for another couple of years!
- N. The Board recognized the contributions and leadership of outgoing NHBA President Marilyn McNamara.

C. Request of the Elder Law Section to file an Amicus Brief

Kerri Glover John Laboe

Kerri Glover and John Laboe, representing the NHBA Elder Law and Estate Planning and Probate Section, explained to the Board the Section's request to file an amicus brief in a matter pending before the New Hampshire Supreme Court.

Their belief is that this is strictly a statutory interpretation (RSA 464-A: 43) and an incorrect one.

There were a number of questions asked by Board members and answered by both Attorneys Glover and Laboe. Attorney Glover did inform the Board that June 22 is not the date by which an amicus brief is due. That is the date by which the attorney's brief is due to the Supreme Court.

Attorney's Glover and Laboe thanked the Board for their time and interest and provided relevant file copies. The file is being held at the Bar Center until there is some direction from the Board. President McNamara explained to Attorneys Glover and Laboe that the Board would further discuss this matter at their June 24<sup>th</sup> Board Meeting and follow-up with Section Chair Sarah Ambrogi after that meeting.

After Attorney's Glover and Laboe left, the Board discussed the issue at length. Many members around the Board table felt there was not enough information and many unanswered questions at this time.
