# E. Possible Court Funding Litigation

Two of the counsel team for the plaintiffs in a soon to be filed lawsuit to compel the state to devote adequate resources to the justice system discussed the suit. The suit will be brought by individual plaintiffs, and no "organizational" plaintiffs will be named, primarily due to the issue of standing. The NHBA will not be a party to the suit.

### F. Leadership Academy Update

Twenty-nine applications have been received for 15-16 slots for the inaugural Leadership Academy group. Those not able to participate in the first round will be encouraged to participate in the Association in other ways and to reapply for a future Academy. A great program is being planned.

G. Concerns Raised by Al Cirone re "Full-Time Judicial"
NHBA Membership Status

The Board received a letter from part-time judge Albert Cirone expressing concern about the Association's application of "Full-Time Judicial" membership status to several part-time judges. Executive Director Jeannine McCoy noted that the letter author is correct in noting that, while the judges in question had given up their law practices and were essentially working as full-time members of the judiciary, they did not meet the NHBA Constitutional definition of being "wholly prohibited by statute from engaging in the practice of law". The background of "Full-Time Judicial" membership status, its general application, and its application to several "essentially full-time" judges was explained. This matter will be placed on the agenda for the October 5 meeting of the Association leadership with the Supreme Court bench.

H. NHBA Insurance Agency Board Recommendation re: Russ Hilliard Asking Supreme Court to again consider *Required* Professional Liability Insurance

Russ Hilliard, President of the NHBA Insurance Agency, Inc. Board of Directors, reported that the NHBA Ins. Agency Board has raised the question of whether or not the Association should ask the Court to once again consider requiring professional liability insurance (PLI) for NHBA members. The question what constitutes adequate insurance coverage in light of deductibles, and self-insured deductibles, was also discussed. It was determined that the Association will first ask the Court for permission to once again conduct a voluntary PLI survey in conjunction with the June 2011 membership dues and court fees collection process.

Association ABA Delegate Russ Hilliard reported that the ABA is developing a "model Civil Gideon Act" for states to consider adopting.

Vice President Larry Vogelman reported on a concept for a committee of volunteers to assist members with personal crisis situations. The "Solace Program" concept was discussed during meeting of bar leaders in conjunction with the ABA Annual Meeting, and will probably be developed in New Hampshire through the Lawyers' Assistance Program.

Excerpt From May 20, 2010 BOG Minutes:

The **Board approved** a recommendation by the Task Force to fund a part-time reporter to assist it with completing its work. At a meeting earlier this spring, the Task Force discussed its work to date, and the pace of progress in completing its work. The Task Force is planning an all-day retreat to review and organize the Instructions completed so far. The reporter will take the results from the retreat and make the necessary edits based on the task force's decisions. Three additional members, including a new chair, need to be appointed to help the task force complete the initial project.

### Update as reported in the 9/15 NHBA *e-bulletin*:

The Drafting Committee of the Bar's Task Force on Criminal Jury Instructions has released over 260 pages of draft instructions. The task force continues to meet regularly to review new legislation and case law that may then require new instructions or modifications to existing instructions.
