ABOUT THE PROGRAM

The New Hampshire Bar Association's Leadership Academy is a nine-month leadership training program designed to foster the professional growth and enhance the leadership skills of a diverse group of attorneys. No more than eighteen applicants will be selected for each Class.

This leadership program is designed with a curriculum that is most meaningful for those attorneys who have been practicing law between three and 10 years.

Participants meet from October to June, including at NHBA's Midyear and Annual membership meetings. Modules cover a variety of topics, including Business, Media Relations & Public Speaking, Judicial Branch, Public Interest/Non-Profit, and Legislative/Executive Branches.

Leadership Academy alumni are actively involved in NHBA Sections, Committees, and the NHBA Board of Governors. They have also taken on added responsibility at their firms and participate in various non-profit boards.



PROGRAM HISTORY

On August 12, 2021, the New Hampshire Bar Association's Leadership Academy welcomed the 2022 class during a reception held at the Grappone Conference Center in Concord. The event marked the twelfth year of what has become, by all accounts, a highly successful program.

Creating a program that would foster leadership, civic engagement, and long-lasting relationships were the goals that then Bar President Richard Uchida had in mind when he first envisioned Leadership Academy during his 2005-2006 presidency.

"I had seen other leadership programs in the country, but at the time, both nationally and in New Hampshire, there was a concern we weren't providing the type of mentorship and leadership opportunities for younger lawyers we needed," Uchida says.

The NHBA's Leadership Academy, which began in 2010, was the result of Uchida's vision as well as the inspiration of 2010 Bar President Jennifer Parent.

Given a shared understanding of the need for a leadership program, the pair created a steering committee that would eventually allow the program to become a reality.

"Knowing that I'd wanted to do this, Jennifer asked if I'd be a part of the process," Uchida says. "One thing we'd heard was that these types of programs couldn't be accomplished without tens of thousands of dollars of resources, but we were determined to create an academy that was very effective that didn't require the devotion of so many resources that it became inefficient. So, with Jennifer's help, and other Bar leaders we created the Leadership Academy during her tenure as Bar president."

In a 2010 interview in the Bar News, then President Parent summed up the need for a Leadership Academy in New Hampshire.

"Leaders aren't born, they're made," she said.

Parent goes on to describe the economic and cultural changes in the legal community that

necessitated the creation of the academy. For many years, she said, building leadership and the tools and desire for civic engagement in individuals, was done informally.

One of those individuals today is Israel Piedra of Welts White & Fontaine PC in Nashua. Piedra, 31, who was elected to the New Hampshire state legislature, is a member of the 2022 Leadership Academy class. He said he's excited to form lasting relationships with those he meets in the Academy and that he's also interested in learning about "non-legal" things, such as developing business-management skills.

"I think the Academy will help me become a more well-rounded lawyer and leader," he said.

The true measure of the program's success, Uchida says, is to look at the graduating classes over the years and to notice how many have gone on to take leadership positions in New Hampshire, in their community, and in the Bar Association.

Two of the many graduates of Leadership Academy include NHLA Director Sarah Mattson Dustin (Class of 2011) and Bernstein Shur attorney Talesha Saint-Marc (Class of 2015).

Saint-Marc, who has co-chaired the program's steering committee for several years now, says going through the academy allowed her to build lasting relationships with other

New Hampshire attorneys that have turned into referral sources, information resources, and friendships.

“I joined Leadership Academy to learn more about the Bar Association, to enhance my leadership skills, and to meet other NH lawyers,” Saint-Marc says, adding that the academy strives to accept a class that is diverse in experience, background, and practice area. “Although Leadership Academy imparts leadership skills, we value participants with prior leadership experience and/or engagement.”

For Mattson Dustin, who also serves on the steering committee today, the experience of Leadership Academy allowed her to get to know practitioners from around the state whom she says she would likely never have met.

“It has been wonderful to watch many of them accomplish great things in their professional lives and as community leaders,” she says. “Some of my classmates have become dear friends.”

Mattson-Dustin also commented on the way the academy encouraged participants to become involved with Bar committee work.

“I joined the Legislation Committee and really enjoyed it – I think I was a member for three or four years. It was yet another wonderful way to meet folks I probably never would have met otherwise, this time including lots of highly experienced attorneys.”

What began, for Uchida and other Bar members, as an idea about building long-lasting relationships and providing opportunities for civic engagement for New Hampshire attorneys, has consistently demonstrated its value, Uchida says. “From its conception, the Court, the Governor’s office, and the Board of Governors were solidly behind the Leadership Academy because they recognized that without this kind of program we weren’t able to provide these opportunities.”

SCHEDULE

Leadership Academy participants are involved in a rigorous nine-month program exposing them to various facets of New Hampshire legal practice. They are also expected to work on and complete a project enabling them to use and demonstrate the skills they have acquired.

- Fri, Oct 22 & Sat, Oct 23: **Kickoff Retreat**
This weekend event provides an uninterrupted and unrushed opportunity to introduce participants to the program and to each other.
- Thu, Nov 4: **Business Module**
What does leadership in the legal field mean? What opportunities for meaningful involvement are available? What's so unique about NH? This module answers these and other important questions.
- Thu, Dec 2: **Media Relations & Public Speaking Module**
Bar leaders know how to work effectively with those who report the news. In this module, participants will meet, hear from, and be able to ask questions to the media and to attorneys who have worked with them.

2022

- Thu, Jan 6: **Judicial Module**
The relationship between attorneys and the judiciary is vital to ensure the efficient administration of justice. Leadership Academy participants will meet judges, tour courts, and learn more about the judicial process.
- Fri, Feb 18: **Attendance at NHBA Midyear Meeting**
- Thu, Mar 3: **Public Interest / Non-Profit Module**
This module provides an introduction to some legal oriented non-profits and charitable organizations in NH, including their purposes, the services they provide, and their leadership roles within the communities they serve.
- Fri, Apr 8: **Legislative/Executive Branches Module**
Change happens through the actions of any of the three branches of government. Here, participants learn more about how the legislative and executive branches function.
- Fri, Jun 17 - Sun, Jun 19: **Attendance at NHBA Annual Meeting (Graduation)**
