ACTION

On motion to accept the consent agenda with the below edit to the July 8th minutes. Passed, with two abstentions, Lindsay Courtney, and Barry Schuster. The July 8th minutes were revised to reflect Belknap County Governor Jesse Friedman's attendance at the meeting.

PRESENTATION/ACTION ITEM

D. NJ Bar Request- Daniel's Letter

George Moore

Executive Director George Moore discussed this request. It arises out of the incident in New Jersey where someone came to a federal judge's house and shot and killed her son and wounded her husband. This legislation would provide a higher level of protection of the personal information of federal judges. George notes that this is the first time that the NHBA has been asked to lobby the congressional delegation since he has been executive director. The timing is such that we need to act on it soon. He feels that there is no downside to supporting this legislation. There was also a recent incident of a judge here in New Hampshire that received death threats after a case. He believes that we should actively support the legislation and that the bar president should write a letter in support.

The board discussed this request. A concern was expressed that there might be a part of the bill that would be controversial under the constraints on NHBA lobbying activities outlined by the Chapman decision. This would be in the nature of a rider or unrelated provisions.

It was suggested that the letter contain a line or two that also references the peril of state judges. The NHBA has been asked to contact only Rep. Chris Pappas, but the board feels we should contact our whole delegation. (Rep. Kuster has already signed on as a co-sponsor of the bill.) It was shared that there currently is a process in place that provides protection for federal law enforcement officers so the cost might not be as high to add judges.

ACTION

On Motion that we send the full content of the bill to the NHBA Legislation Committee for review for Chapman issues and then send their conclusions to the board and conduct an online vote. If there is a favorable response, this would include a letter to be sent to the congressional delegation. Passed. Unanimously.

This ended the regular board of governors meeting. The group then moved into the orientation portion of the day.
