President-Elect Kate Mahan called the meeting to order at 4:04 p.m.

D. Proposed legislation by Real Property Law Section

Michelle Radie-Coffin,  
Chair of the Real Property Section/  
Laura Dodge, Vice Chair of the Real Property Section/  
Attorney Gregory Michael

President-Elect Kate Mahan introduced Michelle Radie-Coffin, Laura Dodge, and Greg Michael. Michelle spoke about the proposed legislation. The section felt this was the most important thing they could put forward as a group last year. The officers ran for reelection, so they could continue work on this proposed legislation.

Michelle shared that the Section thinks this legislation is important beyond the interests of the members of the section and the members of the bar, because it would provide protections for the consumer. There is not a current statutory framework that allows these old mortgages to be discharged. This creates a problem if the mortgage cannot be discharged, due to the bank having gone out of business or records not being available. This is really problematic for consumers, who have to file a quiet title action to get clear and marketable title to their property.

Greg Michael spoke about the effect on consumers. He spoke about the current statutory framework that applies, and the problems that it created. This is frustrating and always comes up at the last minute at the time the money is supposed to be paid. He feels they should try to improve this situation by the proposed legislation. He thinks that if the banks knew they didn't have an open-ended time frame with no limit, they would work harder to create a non-discharge record.

Laura added that this was the number one issue flagged by the Section, and they are hoping for the Board's support in bringing this forward to the legislature. These problems delay closings and are costly.

The Board discussed the issues and possible action. The LSR (legislative services request) has not been filed, as Board approval is needed first. The Section has approached the mortgage bankers association and have preliminary buy in, but they are not sure about the NH banking department's position.

There was discussion about whether the deadline for filing LSR's for the upcoming session has passed. There was a question about the requirement for mortgagor and mortgagee to both sign, and its implications. Michelle responded this was intentional. Greg added they will look at this section and perhaps adjust it.

Another Board member asked whether there might not be substantial unanimity across the bar (Chapman problem) and thinks this should be considered.

Executive Director George Moore doesn't think there is a Chapman concern that would prevent the NHBA from taking a position, as this would improve the justice system. Unless there is a substantial number of members that opposed it, it would not present a problem. The Chapman case was concerning tort reform, and there were supporters and opposers in equal number.

Board Member Lindsay Courtney asks if we have time to consider this request, since the window for submission of LSR's has closed. The Board can vote today or give it 30 days and have them amend the language and take action next month.

Board Member Chris Regan would like to know how the banking department feels about this before voting on this request. Board Member Lindsay Courtney would also like more time to consider the request. She thinks the banking department won't weigh in, as generally state agencies do not take a position on pending legislation.

### **ACTION**

On Motion – To table the decision for 30 days. Passed.

The suggested revision will be made, and the Section leaders will come back at the November meeting to present it and a vote will be taken at that time.

- E. Appointment of 603 Legal Aid Board **ACTION** Melinda Gehris, Board Chair  
Emma Sisti, Deputy Director

President-Elect Kate Mahan introduced Emma Sisti and Melinda Gehris. She referred to the memo provided in the Board materials.

Melinda stated they are here for two reasons. The Legal Services Corporation (LSC), which is the federal entity that provides funding to 603 Legal Aid, requires that the NHBA Board of Governors approve the nominees to the 603 Legal Aid Board that are attorneys. She said they will return in the spring of 2024 to request approval again and will do so every year going forward in the spring. Board Member Lindsay Courtney asked how members are solicited to serve on their board. The regulations state that the NHBA has to appoint these people, and she thinks it is unique that 603 selected the nominees, and not the NHBA. Melinda responded that they are trying to fix a problem and get a board in place. They would be happy to work with the NHBA on this in the future. She stated that they would also like suggestions for client non-attorney members of their board, which is another LSC requirement.

Executive Director George Moore added that we have traditionally approved board members for LARC in the past, when they were the recipient of the LSC funding. When the merger of LARC, NHLA and Pro Bono happened a few years ago, this requirement was overlooked. 603 Legal Aid is now seeking to correct this oversight. Emma Sisti thanked the Board of Governors as well as the attorney members of the NHBA for their support. October is Pro Bono month. They can't do this work without the Board's support, she stated.

### **ACTION**

On Motion to approve the nominations to the 603 Legal Aid Board. Passed.

- F. Petition to support televising the trial of Donald Trump George Moore

George spoke about this petition that was sent to the Board requesting that the trial be televised. He has seen no activity from the federal court amending their rules. This is at the heart of the administration of justice, but if there isn't substantial unanimity it could present a problem for the NHBA. George was asked to check with other mandatory bars as to whether they have received similar petitions.

He thinks we should discuss, but table a decision for 30 days so we can discern if other mandatory bars have had this issue brought to them. He will report back to the Board in November.

President Paul Chant believes there are Chapman concerns, and whether we endorse it or not, it won't matter to the decision makers. Taking a position has more risk.

The Board discussed the potential Chapman concerns, whether their decision would have enough of an impact to be worth the risks. Some felt this question will end up at the US Supreme Court regardless of any petition submitted.

### **ACTION**

On Motion that the question be tabled for thirty days, and bring in additional information at next month's meeting. Passed with one abstention, Jonathan Eck.

#### **G. Report of the NHBA Waiver Committee ACTION**

Paula Lewis

Deputy Executive Director Paula Lewis stated this is a report of all waivers that were requested this year. There were more denied than approved as there was no evidence of hardship in many of the requests. Board member Jim Shepard, also a member of the NHBA Waiver Committee, spoke about the rules the committee follows when deciding whether to grant waivers. The committee only considers financial hardship. The NHBA Constitution, in Article II, Section 7, says the Board can "...in any case in which to do otherwise would result in hardship or injustice, abate dues in whole or in part, and waive delinquency fees....". Some had a good reason for missing the deadlines. The decisions of the NHBA Waiver Committee can be appealed to the Board of Governors. Paul Kleinman, also a NHBA Waiver Committee Member, feels the Board needs to address some of these issues.

Paula added that the waiver committee struggles with these requests. The first show cause hearing date is November 6<sup>th</sup> at the Supreme Court and there is another in late November. There are over 400 attorneys that did not come into compliance by the deadline. This number is more than double the number of last year. As of this writing, there have been no appeals to the Board.

Executive Director George Moore stated we should schedule a bench bar meeting with the Supreme Court to address whether there needs to be a mandatory education program for lawyers to help solve this problem of so many attorneys not completing their licensure requirements on time.

This is a problem for both the bar staff and the court staff. He shares that there were 1000 members that weren't in compliance by August 1<sup>st</sup>. The deadline is July 1<sup>st</sup>, but under the current system, no delinquency fees are assessed until August 1<sup>st</sup>.

Justice Gary Hicks, NHSC Liaison to the Board of Governors stated that he will discuss a rule change that imposes a drop dead date with Justice Donovan, who oversees the NH Supreme Court Rules Committee.

Board member Lindsay Courtney asked why attorney licensure isn't treated like other professions in NH that license their practitioners. No other profession enforces their licensing requirements in this way. They all have an expiration date for their licenses, after which they are suspended from practicing. Lindsay is Executive Director of the NH Office of Professional Licensing.

George says the NHBA will pursue some changes to this rule to help mitigate the problem. He thanked the NHBA Waiver Committee members for their work. He says if they feel there are changes needed in the waiver procedure, they should suggest them to the Board.

### **ACTION**

On motion to approve the report of the NHBA Waiver Committee. Passed.

#### **H. Treasurer's Report**

Chris Regan /Paula Lewis

Treasurer Chris Regan suggested the Board read the Treasurer's report provided by Deputy Executive Director Paula Lewis. Chris spoke about the highlights. The balance sheet is an overall statement of the health of the organization. He explained restricted and unrestricted cash amounts. The income statement gives more detail about what is going on with the organization. He noted there are a large amount of non-payment of dues delinquency fees, \$55,000 more than budgeted. Chris also noted that we are not getting as much income from live CLE programs, and more of our revenue is coming from online programs. We will keep our eyes on this. Our expenses are on target.

Paula added that there was a CLE committee meeting last night, and she shared the financials with the committee. Lisa Deane, who is assisting with our CLE program until we hire a Director, reviewed them with the committee, and we have a good amount of program offerings planned in the coming months. The committee is meeting more often, there is a push for the committee to plan more CLEs and get the information to our marketing department in a timely manner. The CLE team and Member Services Supervisor Misty Griffith have planned some very good programming. She feels the deficit we are currently seeing will dwindle over the coming months.

Paula also spoke about our ongoing audit. Our auditors will be sending questionnaires to Board members – please respond in a timely manner. Also, please return them to our auditors Nathan Wechsler and Associates as directed. Please don't send them to Paula to review, as she cannot review it.

#### **I. President's Report**

Paul Chant

Paul spoke about the plans for the upcoming Midyear Meeting. It is scheduled for February 9<sup>th</sup> at the Doubletree Hotel in Manchester. He urges Board members to get it on their calendars. He is looking forward to a great, mixture of programs on both attorney wellness and AI. We are considering a nationally known speaker on AI, and a speaker whose organization is Lawyer Brain.

Paul said he is hearing extraordinarily positive things about the Bar's CLE programs and Lisa Deane's involvement.

He also reported that the bar's new Special Committee on Attorney Wellness had their first meeting yesterday. There is some good focus and good energy in this group.

Lastly – Paul reminded the Board of the call for nominations for the awards at given at the Midyear Meeting. Deadline for nominations is November 21<sup>st</sup>. He would love to have good nominations to

choose from. The awards given are the Vicki M Bunnell Award for Community Service; the Distinguished Service to the Public; and the Outstanding Service in Public Sector/Public Interest Law.

Paul also asks members to let him know about local county bar meetings that are planned. He would like to attend as many as he can.

- J. Executive Director's Report George Moore  
1. Update on lower-level Seminar Room project

George shared that the Members Only area is 95% complete on construction. Furniture should be in by early November. We hope to have an open house by our next Board meeting. George thanked Paula for her hard work on this project.

George spoke about the Lower-level project. We have signed the contracts for the construction and technology improvements. The project involves replacing all the lighting, changing the stage and improving cameras. We will now have two-way communication, which will enable webcasts and hybrid meetings where those participating online can communicate with those in the room. We are hoping the work will be done during the holiday season when no CLE programming is scheduled. We expect the renovation work will extend into January.

Chris Regan reported that the Strafford County Bar had a reorganizational meeting last month. They held elections and hope to have a Christmas party.
