A. Call to Order Sarah Mattson Dustin

Vice President Sarah Mattson Dustin called the meeting to order at 4:10 p.m.

C. Ankur Doshi from the Oregon Bar – re: unification challenges

President-Elect Robert Lucic joined the meeting and introduced Ankur Doshi, General Counsel of the Oregon Bar Association. Attorney Doshi leads the regulatory team. Executive Director Blodgett invited Attorney Doshi to present on challenges facing mandatory bar associations. The Oregon Bar Association is in active litigation so he cannot comment on some issues.

Oregon is a unified bar. They handle regulatory functions, including both admissions and discipline. He also noted that the Oregon Bar has a required mentoring program which is mandated by court rule. Attorney Doshi discussed the different types of bar associations, voluntary, mandatory, and integrated/unified and the difference in their functions. The latter two require attorneys to join and may or may not be responsible for regulatory in addition to membership functions. There are approximately thirty unified bars in the United States currently. Of the 30 mandatory bar organizations within the United States, seven have had challenges in the last five years.

Attorney Doshi discussed unification challenges that bars have faced. He began with the Keller case Keller governs the balance of the Bar's compelled membership and the First Amendment. The question had arisen as to whether bar associations are considered governmental organizations. The California Bar argued that it was a governmental entity, and therefore subject to the governmental speech doctrine, which protected governmental programs from First Amendment review. The US Supreme Court disagreed and found the California Bar acted more as a labor union, specifically a public sector labor union, for purposes of constitutional review. Under Keller, dues collected under by a mandatory bar association can only be used in regulating the legal profession and improving legal practice. Dues from a mandatory bar cannot be used for "activities of an ideological nature which fall outside of those areas of activity." Questions about whether an activity is germane to the practice and relates to the regulation of law have followed this decision. The evolution of the law in this area is that the law continues to be unsettled. Attorney Doshi stated that he is hoping future litigation will provide clarity. He then discussed the Janus case, which overruled the Abood decision. Janus found that the "germaneness" test did not survive exacting scrutiny, and that individuals could not be compelled to fund an association that they did not want to associate with. This has created a target on Keller's continued constitutionality.

There was a question about how much the regulatory functions of the California Bar played a role in the decision. The NHBA does not have the same regulatory functions. Attorney Doshi responded that this was not taken into consideration. The focus was whether the Supreme Court rule compels membership in order to practice law. He noted that the Wisconsin Bar status has been challenged multiple times and upheld. They are not responsible for any regulatory functions. It is the membership function that has created these issues rather than the regulatory function.

Attorney Doshi then discussed the status of current nationwide litigation. He reviewed a number of cases starting with *Fleck v. Wetch* (2018 North Dakota), in which there was never a decision as Janus was decided shortly before it was to be considered. The case that triggered a large amount of litigation was the Jarchow v. State Bar of Wisconsin, in which Justice Thomas' dissent in the petition for certiorari noted that mandatory bar organizations should be reconsidered. There have been eight challenges to unified bars, two to Wisconsin in the past 5 years. These challenges have been on multiple grounds. One such position is that Keller test does not meet exacting scrutiny under Janus – based on the rationale of Janus overruling Abood. Currently the 5<sup>th</sup> circuit has the most conservative approach. This Court has found that Bar programs on wellbeing, and diversity and inclusion are not germane.

The Keller case impacts sections and committees in programming, communications, donations and legislative advocacy. Oregon uses the Keller decisions as a framework for making decisions about programming. Threshold, substance, germaneness, and polarization are the tests they use.

Attorney Doshi has been tracking the litigation since he began at the Oregon bar. Oregon's litigation has been ongoing for 7 years. He started this job after the litigation started. Their Supreme Court has not wanted to take up this question.

There was a question whether any cases have addressed if peer review of judicial nominations were germane under Keller. Certain reviews were found to be germane in the early 2000s but Attorney Doshi is not sure of current status.

D. Resolution to Amend Bylaws Article II, Section 7 Limited Active Membership

## E. Report of the NHBA Waiver Committee - ACTION ITEM

Controller Jennifer McManus discussed the report and the waiver process. The report was posted with the other Board materials. There was a question about the standard for waiving dues and fees. The committee looks at the need and financial situation and what is presented to the committee. There was also discussion about the frequency of repeated request from the same attorneys. There are some but not as many as one might expect. The association tracks repeated waiver requests. Governor at Large Jim Shepard, who is a member of the committee, stated that the ones that come back more than once are usually very well founded and are experiencing some kind of personal tragedy.

## F. Treasurer's Report – **ACTION ITEM**

Geoff Gallagher, Jennifer McManus

Controller Jennifer McManus gave the report this month. She encouraged the Board to review the report narrative. She highlighted the high amount of restricted cash on hand, as we have just completed the annual member renewal season. She also noted the income statement revenue section, Member Fees and Discounts showed a loss in the prior fiscal year of \$86,000 and the same line now shows an \$800 loss. This is because we moved the InReach processing fees to expenses under overhead expenses, which is the proper location as this is considered an expense. Controller McManus also reported that under overhead expenses the credit card fees are now broken out. The prior year was zero, and currently the line shows \$13,000 as we implemented fees at the start of this fiscal year. Lastly, she reported that we have adjusted the method for budgeting CLE revenue. We now budget based on when we historically receive revenues rather than breaking the monies out evenly over 12 months.

## G. President Report

Derek Lick

We have all the committee assignments set including civics. President Lick stated there will be an executive session virtual meeting in early November regarding the judicial process and encouraged Board members to respond to the meeting time poll that was recently sent to them.

## H. State Update

All Board Members

Board members are asked to report on issues of concern or interest for Association members that should be brought to the attention of the Board of Governors.

- Grafton County Governor Barry Schuster announced there will be a meeting of the Grafton County Bar Association on October 29<sup>th</sup>.
- Board Secretary Cathy Shanelaris announced that Judge Spony is hosting an event tomorrow at the courthouse in Nashua regarding mental health issues.
- Treasurer and Ethics Committee member Geoff Gallagher shared that the Ethics Committee is continuing its work on the Rule 1.17 revisions regarding sale of a law practice. He is asking on behalf of the committee for clarity on whether the Board thinks the rule should also apply to mergers. The current

rule is restrictive; it requires the attorney that has sold their practice to no longer practice law in NH. Additionally, there is a question about whether the rule applies to a merger or not. A related issue is whether the attorney is in active or inactive status. The current court rule could lead to confusion. The Ethics Committee may model their opinion on the ABA rule.

President-Elect Lucic asked about the purpose of the current rule. Is it to ensure notification to the clients? Ethics Committee Member Gallagher responded that the burden is currently on the seller to provide notice to the clients before the sale. If a seller wishes to avoid this burden they might consider a merger rather than a sale. There was discussion about the practical problems with the required client notification. The goal is to have the draft that comes out of the Ethics Committee be accepted by the Board.

President-Elect Lucic suggested that we synchronize the Rules of Professional Conduct and the Supreme Court rule. The goal seems to be client protection. He added that the Board will think about it and discuss the issue further at a future meeting.
