



## **JUSTICE FUNDS**

Advancement of Justice Fund supports civil legal services to the disadvantaged, for public education relating to the courts and legal matters, to advance the science of jurisprudence, and to improve and promote the administration of justice.

Advancement of Justice Restricted Fund supports civil legal services to the disadvantaged, for public education relating to the courts and legal matters, to advance the science of jurisprudence, and to improve and promote the administration of justice.

William A. Baker Fund supports pro-bono legal assistance for disadvantaged people in New Hampshire.

Hon. William F. Batchelder Fund supports legal services for low-income and other disadvantaged people in New Hampshire.

Stanley M. and Thalia M. Brown Fund supports public education about the law, with an emphasis on educating the legislative and executive branches of government about the justice system in New Hampshire.

Richard P. Dunfey Memorial Fund supports civil legal services to the disadvantaged, for public education relating to the courts and legal matters, to advance the science of jurisprudence, and to improve and promote the administration of justice.

Vickie Bunnell Memorial Fund supports legal services for low-income people, public education about the law, and the administration of justice in the North Country. Preference will be given, but is not limited to, projects which address the prevention of violence in the family and the community.

Judge Richard F. Cooper Fund benefits disadvantaged children and youth in the Rochester (NH) area. Distributions are to be made through the New Hampshire Bar Foundation, its successors or other local agencies serving these children or youth.

Dean Trust Fund provides prisoners at New Hampshire State Prison, or persons accused of crimes, a means of telling their story relating to the crime for which they are imprisoned or charged, through the newspapers, periodicals, radio, television or other methods of communication. Net income is distributed annually to New Hampshire Bar Foundation to support a program directed at specific purposes of the Dean Fund.

J. Albert and Mildred E. Lynch Fund supports education relating to property rights in a free society.

A. J. McDonough Family Fund supports efforts to address the legal needs of New Hampshire's senior citizens, with an emphasis on projects that provide information, education, and advice about healthcare and nursing home alternatives, legal rights, and asset protection.

Arthur & Esther Nighswander Justice Fund The purpose of this Agency Fund is broad charitable purposes with a preference for programs and projects which educate participants on the principles and history of the United States Constitution, with particular emphasis on civil liberties and civil rights.
